Pursuant to requirements of the Georgia Constitution, Attorney General Christopher Carr, Secretary of State Brian P. Kemp, and Legislative Council of Georgia, are hereby publishing the summaries of the proposed constitutional amendments that will appear on the November 6, 2018, general election ballot for consideration at the polls.
