His eyes were huge and he was dancing a chair jig with the prospect of eating the pancakes laden with large red gooey strawberries and whip cream. Paulie looked up at me

In the future I wonder what people will say about our lives today. Will our lives and efforts be relevant? One of the goals of the Canning Plant is to serve as an incubator to the local foods business in Northeast Georgia.

For example, the Georgia Cooperative Extension Office will host a Better Foods Processing Training and Certification at the Community Center on Jan. 22-23.

The training session is designed to certify Food Processors in the manufacture of acidified foods (pickles, relishes, etc.). Why is this training needed? Any person who sells these kinds of foods must be trained and certified by UGA and the FDA to sell the foods. It is the law. People have been eating these types

of foods for years with no adverse reactions, including me. But, when someone begins mass producing items for sale there is always a chance something could go wrong.

Someone told me the other day, "Well, I can always open the jar and smell if something is wrong with the food."

That is incorrect; your nose cannot detect botulism. You can only detect spoiled food which does not kill. So, in an effort to help people be safe and become certified processors we will hold the training.

The cost is \$275 which covers all supplies, testing procedures, two meals and breaks. After you take and pass the tests you will become an Acidified Foods Processor. For more details please call the Extension Office at 706-439-6030.

Eighty years ago Adolph Hitler assembled a machine that was responsible for the most disastrous social disruption in the history of mankind. At first, a majority of Germans didn't "buy into" Hitler's concept of world domination. To implement the plan, Hitler named Joseph Goebbels as Minister of Public Enlightenment and Propaganda. Goebbels instituted a cunning program that included deception, lies, intimidation, racism, and violence. It worked as evidenced by the horrific human tragedy that followed.

One of Goebbels' favorite techniques was to construct an alternative reality. This allows you to transfer your own shortcomings and untruths to someone or something you wish to discredit. By inventing your own "facts" and repeating these lies often enough it is possible to mold public opinion.

Hitler and Goebbels are long gone, but their message of hate and deceit seems to live on.
