### Q. What is Environmental Health and is it a part of the Health Department?

A. Environmental Health is a part of the Health Department, but it is located in the "old" Health Department Building located at 46 Hughes Street, Suite B. Environmental Health Services includes water testing, rabies control, inspections of restaurants and hotel/motels and they also issue septic permits.

### Q. What are the hours of operation for Environmental Health?

A. Environmental Health is open Monday through Friday from 7:30 a.m. to noon, and from 1 p.m. to 4:30 p.m. You must arrive 30 minutes prior to closing. Call (706) 781-3824.

### Q. Do you have any statistics on how many people are served by Environmental Health?

A. In 2012, Environmental Health Services provided 2,306 total services.

### Q. Do you have similar statistics for the Health Department?

A. Yes, in 2012, 5,362 clients were served by the Health Department, which was 25 percent of the population of Union County (in 2011, 21,134).

In 2012 total visits were 9,609 and total services were 34,160.
